The deputation will be initially for a period of 03 years and likely to extend further. The applicants may forward their applications (in prescribed format only) through proper channel alongwith NOC, Vigilance Clearance and APARs for the last five years.

Following instructions may be read carefully before submission of the application for deputation:

1. Envelop containing application should be super-scribed with "APPLICATION FOR THE POST OF _____".
2. The pay of the officials selected will be regulated by CCS (RP) Rules, 2016 (amended from time to time) and the maximum age limit for appointment on deputation shall be 56 years on the date of closing of the applications.
3. The Pay Level of the official shall be reckoned to the post only for the purpose of requisite service prescribed in the Recruitment Rules. Pay Level granted by virtue of ACP/ MACP to the applicant shall not constitute his / her eligibility for requisite service in the particular Pay Level.
4. The deputation will be covered by standard terms and conditions as applicable from time to time.
5. The Director, National Bal Bhavan reserves all rights to reject any or all the applications and not fill up the deputationist posts without assigning any reason.
6. Interested candidates presently serving in Central Government/ State Government/ Autonomous Organisations/ Equivalent cadre of Govt. of NCT of Delhi and keen to serve on deputation may please apply within prescribed time limit in the enclosed proforma (Annexure-A) available on National Bal Bhavan website i.e. www.nationalbalbhavan.nic.in alongwith passport size photograph duly pasted on the application form, self attested photocopies of educational certificates. The controlling department while forwarding the application may ensure that requisite service of the applicant, NOC, Vigilance Clearance and APARs of the last five years, etc. are attached duly authenticated by the appropriate authority, failing which application will not be entertained. The applicant should bring the testimonials in original of all the qualification and requisite service in the relevant area over and above the minimum prescribed qualification at the time of interview.
7. No TA/DA shall be paid to the shortlisted candidate for attending interview.
